### 10. THE PRIORY OF WORKSOP

The priory of Worksop for Austin Canons, according to an old chronicle cited by Dugdale, was first founded, probably after a humble fashion, by William de Lovetot in the year 1103. ([fn. 1](#))

The fuller endowment charter of Worksop Priory is in the hands of Colonel Henry Mellish of Hodsock Priory. ([fn. 2](#)) By this charter, of the reign of Henry I, c. 1130, William de Lovetot, with the assent of his wife Emma and of his sons (Richard and Nigel) granted to God and the Holy Church and to the canons of St. Cuthbert of Worksop all the chapel furniture (*capellaria*) of his house, with the tithes and oblations; the church of Worksop, where the canons were, with lands and tithes and all that pertained to the church; the fish-pond and mill and meadow near the church; the whole tithe of his customary rents, both in Normandy and England; a carucate of land in Worksop field, *ad inwara(m)*, ([fn. 3](#)) and his meadow at 'Cathale'; all his churches of the honour of Blyth, namely, those of Gringley, Misterton, Walkeringham, Normanton, Car Colston, Willoughby, Wysall, and portion of the church of **Treswell**, with all tithes, lands, and possessions belonging to these churches; the tithes of his pannage, honey, venison, fish, and fowl; and the tithes of malt and of his mills, and of all his possessions from which tithe was wont or ought to be given.

### **Crumwell (Cromwell)**

Item, they say that the church of Cromwell is taxed at 20 marks, and the ninth of sheaves, lambs and their fleeces are worth 13 marks a year at true value and no more, and that the arable land and meadow there are worth 5 marks a year, and the tithe of hay with altar dues is worth 2 marks a year.

Mandate to do justice touching the dean and chapter of York, who, having appointed Henry de Baghton to a moiety of the church of Tyreswell, presented him to the archbishop, who refused the presentation, and gave the said moiety to John de Castesden, who, in spite of an appeal to the pope, held it by violence, and cut off the tails of the horses of the chapter, and of those of Henry's proctor and notary, whom they so evilly entreated that they hardly escaped with life.

1589 - Wm Thornton refuses to pay the clerk his wages AN/PB 292/2/folio 8r/11

1603 - Minister and churchwardens present the following: 1. our minister is a preacher, being an Oxford man and a M'r of Artes; 2. he has no more benefices than that; 3. [not mentioned]; 4. we have no recusants within our parish; 5. we have 161 communicants and no non-communicants except those who are under age. AN/PB 294/1/258

1607 - Churchwardens present the following: our chancel is not in sufficient repair, but it is in mending. AN/PB 294/2/64

1612 - Churchwardens present the following: our parson Mr Langley does all things fitting for God's glory and his place; Hughe Blakburne is presented for not receiving the sacrament this last year; John Smithe and Ane Tineley, who is now his wife, for fornication together before marriage; William Herdmane and the inhabitants of Treswell for keeping a miller grinding at Ramptone [Rampton] on the Lord's day. AN/PB 295/3/65

1613 - Churchwardens present the following: we cannot tell that the canons have been read according to the first article; we have no service on Wednesdays and Fridays; he [minister] does not ordinarily wear the surplice, but he does sometimes; he omits the litany because he preaches twice every Sunday; he uses the words of the sign of the cross; Willm Lincolne, parson, is not resident with us, but is in Lincolnshire; one Mr Edwardes preached on a workday, Mr Langley knew his name; he [minister] does not read christenings and burials in the church; our minister is a preacher; we have no Homilies or 'Jewells' ['Jewell's Works']; the 'palliter' [apparitor?] told us we should buy it from him, [but] we could not get it; we have a chest with only two locks and another with one, but we take order that one 'pore' [poor box] is provided by the overseers;

Originall Gilbie is our schoolmaster, he came from Worksoppe [Worksop] and has a licence to help Mr Langley to read; Johne Smith [is presented] for grinding corn on the Sabbath day in service time; Edmond Herdson for grinding on the Sabbath day after evening prayer; Willm Herdmane, miller, for [working on] the Sabbath day; many in our parish put on their caps, I think for infirmity; I myself do it for infirmity; John Stirtuant has entertained a separatist for one night or so, but he himself is a very honest man and comes duly to the church; our order of churchwardens has chosen plough day [for new elections] and so continue, but we enter [our presentments] now. AN/PB 295/4/104

1620 - Churchwardens present the following: the church windows are not in repair but are in mending. AN/PB 339/1/70

1623 - One churchwarden presents the following: we are unprovided of a church Bible, one book of Common prayer, a cushion and a cloth and one black table cloth. AN/PB 339/4/6

1625 - Churchwardens present the following: the steeple and bells of the parish church and the church porch are in some decay and want repair; they humbly entreat recipients to give them until next Lammas for the repairs. AN/PB 339/7/44

## 8.

### Cases Concerning Churches.

Christopher Featherstone, of Warsop, who was cited on 10th November 1629, "for wishing the church steeple downe (& when he had paid his church laye with a very ill will) for saying the divell goe with it," alleged "that he did but wish the church on tother side of the water " and was dismissed.

In 1638 a detailed inspection of all the churches in the Archdeaconry was apparently made. Some of the reports are entered in the Act Book for that period in the form of citations against the new and the old churchwardens. The Registrar, no doubt, intended to enter all the reports as vacant leaves were left in the book for that purpose, but unfortunately he did not carry out his intention. The reports that are entered are of such local interest that I have extracted them all in full.

TRESWELL. "The roof of the Chancell standes upon propes & the leades are in decaye, the chancell floore is not even paved, there are disorderly seates placed in the Chancell. The Communion table is sett East and West & there is noe Raile aboute it, the seates in the Church are generally noe way uniforme beinge some higher some lower then others, there are three rowes of formes sett on the northside of the church which stand East & West, the Iles of the Belfray are uneven paved, the font wantes a decent Cover, there wantes a poore mans box & a table of the degrees prohibited in marriage & the Chist wantes lockes & keyes, the Churchyard is not sufficiently fenced, there is much dust and rubbish in the Belfray & there is tresles & formes sett in the great Ile."





Parish church. C13, early C14, C15, restored 1855, tower restored 1900. Coursed rubble, dressed coursed rubble and ashlar facing. Slate roofs with coped gables and embattled parapet to nave, tower and porch. Single brick and stone stack to the north chancel. Set on a plinth with heavy moulded band over. Tower, nave, north aisle, south porch and chancel. Diagonal buttressed tower of 2 stages with string course at the juncture. Single gargoyle to each side. Single arched window with 3 arched lights, string course under and hood mould. There are 4 arched bell chamber openings, each with 2 arched lights, tracery, cusping and hood mould and 4 rectangular stair lights. Projecting from the west of the buttressed north aisle is a lean-to. The diagonally buttressed north aisle north wall with single gargoyle has a blocked chamfered arched doorway with 2 C15 3-light windows to the left, all with panel tracery and cusping under flat heads and in casement moulded surrounds. There is a single similar window in the east wall. The early C14 chancel has in the north wall a single arched window with intersecting tracery, cusping, hood mould and label stops. To the left is an arched doorway. The diagonally buttressed east end has a single arched 5-light window with intersecting tracery, cusping, hood mould and head label stops. The south wall has 2 similar 3 light windows with hood moulds and label stops. Under the right window is a C14 coffin lid decorated with a stylised cross. The south nave has 2 arched C15 3-light windows with panel tracery, cusping and hood mould. The angle buttresses of the porch are decorated with crockets and finials. There is a single ridge cross and an arched doorway with hood mould and human head label stops. The inner chamfered arched C13 doorway has impostes decorated with nailhead and terminating in a scroll. There are 2 human head label stops. Interior. 3 bay double chamfered arched arcade with octagonal piers and embattled corbels to the east and west. Similar corbels support the double chamfered chancel arch and those supporting the double chamfered tower arch are further decorated with blind tracery. Stone carved altar rails, octagonal font decorated with quatrefoil panels. 2 pews have decorated poppyheads. Stone carved angles support the chancel roof. C19 furniture.
